Barasat Institute of Social Activity (**BISA**) has been working for nine years on child development with slum children in Hatkhola under Barasat Municipality of North 24 parganas. We strongly believe on "**A dynamic civil society by implementing the fundamental rights at all levels**, **through the change of behavior of our society**."BISA also works on WASH, RCH, Environment & Legal Aid service for deprive people.

BISA has gathered some pathetic experience through right base activates with children in the community; Major problems are domestic child labor, drop-out children as well as child marriage. **The Child Rights Constitution** under **United Nations** speaks of four sets of civil, political, social & economic and cultural rights of every child without any discrimination. So, everybody knows that the government has taken progressive scheme for these children. But we observe carefully that the needy children are being deprived of this scheme for lack of proper initiative. It is burning problems of our community.

BISA gets support from local community. We have conducted child development program at Hatkhola (indira colony, Parichran Sarkar Colony, Ambedkar coloni) including health and educational Development of slum children. Its also conducting Environment Development Program in deferent areas of Barasat Municipality. BISA is going to start work on rights of third gender. It is related with human rights.

To try formulating a forum consisting of general people with CBO's, NGO's, and honorable elite persons as well as common people to save the fundamental rights of people fromall levels of society.



Education Programme :-

Education Support to 60 children :

Education centre conducted by volunteers of BISA at morning & evening time.30 children come to the centre for received direct education input from the teachers & 30 children get support education material. But 200 children of hatkhola slum children indirect benefited from centre through other social activity. We provide bags, books, pencil, and school dress.





BISA Study Centre: We make BISA Study Centre for domestic & helpless children in slum area at Barasat Municipality under Barasat 2 no block of North 24 parganas. The organization has limitation to properly manage smooth operation and is facing challenges to address some potentialities to give better support for th e children. During reporting period the centre is giving support to 30 children. The centre provides academic education, Cultural education Skill development training as well as tuition fees. Cultural Education: The centre organizes different cultural events to the choice of the students. They are encouraged to take part into the events drawing, drama, Republic Day and observed of 15th August. The children celebrated the different great person who fight for freedom of India. We learn education from their sacrifice life.





Motivation of parents: The centre is working specially for those parents to change their mentality by motivation through visiting their house. More over early four meetings are arranged at a fixed date in time. Parents of centre students gather and proclaim their various valuable opinions there. The volunteers can share with the parents of students on their progress regarding family life and class as well.

Capacity building: 63 children are being participated in these meeting. Topics are:

- Major time of hand wash
- Process of hand wash
- Water born disease

Stakeholder M eeting: BISA has been identified local stakeholder in Hatkhola under Barasat Municipality of North 24 parganas. 15 participated in this meeting. The meeting conducted on Child Need & Child Rights. Our discussion issues are:

- Identified
- > Drop-out children, domestic childlabors.
- > Need assessment of these children.
- Child Education Nutrition

Advocacy with Government key persons: Most of the children son of domestic labor who are deprived from their basic constitutional rights. Volunteers went to government department for arise voice for the helpless children & women. We discussed on gap of need & implementation policy of child & women. Our discussion issues are –

- 1) Drop-out children
- 2) Sponsor scheme support to the domestic child labor.
- 3) Propaganda on child line at Hatkhloa slum.
- 4) City level child protection committee.
- 5) Adolescent girls health &
- 6) Livelihood

Risk assessment: BISA volunteers organized a risk mapping with the children on 12.12.18 in Paricharan Sarkar Colony. Specially focus on girl safety in this area from bad motive person. 23 female children are participated in the mapping. They show interest about the activity. At first one child lay on the gr ound where kept an art paper. All children stand around centrally. One child outlines the shape of body.

Volunteers encourage to the children that draw a picture good touch & bad touch. Most of the participants identified the risk factor & who hampered to them? They feel safe/unsafe .Participants categories risk identified from their group discussion. At the least, all candidates prepared a chart touch matrix of good touch & bad touch.

Entitlements :- With regards to facilitating access to rights & entitlements, **BISA** will continue to liaise with concerned stakeholders to ensure that all babies born to India n families have their birth registered, & that women and children have access to immunization and health care from Government health Institutions.

President of society Dr. Baidyanath Mukherjee, Secretary Dr. Sanatan Bandhyapadhay & Assistant Director Mr. Subhas Choudhury distributed all kits among the slum children at Hatkhola 26 no word of Barasat Municipality.

Sankalpo - ii part for awareness programme whole district. BISA selected for Barasat 1 -2 block & Barasat Municipality. This year focus on reduce Child Marriage, Antitrafficking and Kanashree committee formation, check list of monitoring about complain box. BISA team show video on child marriage and next point participatory process method Appling in the school room where all children participate on discussion .they kept their opinion on the



particular issues. Students use chart paper where one students note on the paper of all students think. They chalk out safety net on human trafficking.

Workshop on DVA 2005: On 24 dec. BISA take initiative a one day District level workshop on DVA 2005 at sanhati library near Hridoypur railway station of Barasat in North 24 parganas under **Unified Law Network banner**. The programme started 10:30am - 5pm. 14 NGO's & resource persons come from deferent corner of district





.Gov't stakeholders women protection officer Ms Anwesha Ganguly,, IC of Barasat women police station Ms Barnani Roy, representative of DLSA Mr. Sasnka Sekhar Mishra, representative of District Bar Association Advocate Aloka Debroy, District cocoordinator of Child line Mr Shibasis Das and Mrs. Sukanya represtative of Swayam participated in this workshop at Hridaypur of North 24 Parganas District.

Awareness programme on DVA-2005: Most of the vulnerable women who victim through violence in community. 50% of women do not own opinion on their best interested. So, they deprived their rights. BISA team takes propaganda on Women rights specially focus on DVA - 2005 in north 24 parganas. Our resource persons conducted awareness programme in different community of the District as a resource person & organized community programme.



Unified Law Network: BISA try to conduct domestic violence against step in society



through legal rights implementing of victim women who do not able lawyer support and counseling support in curtail time face. We organized NGO's of North 24 parganas under Unified Law Network. BISA team want develop skill on DVA - 2005 of client dealing and as per act guide to victim when provided information to the

victim on primary care & Govm't institutional service or linkage with counseling and legal service as well as women protection officer who guide the victim for their constitutional rights.

Celebrate on 8 March: We observed on 8 march at 5pm of hatkhola slum area under Barasat Municipality. Most of the women work as a domestic lebour [paricharika] in Barasat city. They have no minimum wages, no leave weekly and no identity as a worker. Women participants attained in celebrate programme. BISA team focus on dignity of women and call for organized to live. Participants participated in the discussion of their problemlike.

Legal Aids : Our organization **BISA** strongly focuses on Human Rights of poor people. The volunteers go to the mass & organize to them for their fundamental rights which are provided by our constitution. We collect cases on Domestic Violence from different area. In the time BISA contact with clubs and honorable persons in society for formulate a forum to save human rights. Advocate Mr . Somen Biswas has trained to BISA team on Domestic Violence, Women Empowerment and Child Right-2002 at the community centre of Hatkhola. Our volunteers have collected cases related to deferent issues & **BISA'S** lowers try to solve these cases & send to counseling centre for reduce their problem .We meet with the gov't stakeholders for advocacy on the cases.

Skill Development: Two volunteers participated Integrated Crop Management practice (IGM) organized by Vivekananda Institute of Biotechnology at VIB from 16th july to 27th july 2018 of Nimpith Ramkrishna Mission.

Training Organic: volunteers organized a camp on organic cultivation for safe soil & reduce production cost in ulla belt of Barasat block.30 farmers come in the camp. They arise some question about their agriculture related. Resource person facilitated the programme. The programme started 11am to 5pm. Both side discussions:

- 1. Safe soil.
- 2. Soil health card
- 3. Reduce cost





FUND: BISA has not got any institutional grant yet. The fund collects from member's subscription & donation, volunteers as well as our wishes. Case Study: Sakina Khatun was a domestic child labour. She is 19 years old. She is elder daughter of her parents. Her father's name Sahid Gazi & Mot -her's name Sanoka Bibi. sakina has two sisters. Sister next to her is 16 years old, next one is 15 old. For long time her parents are suffering from many disease. So they can't involve themselves properly with their livelihood. sakina, s mother work as a maid servant in some houses. In the mean time, Sakina involved herself with her mother to earn money and to help her family. Subsequently she was detached from education & didn't go to school on regular basis. Sakina was just on the edge to be dropped-out from the school when read class 5. BISA volunteers identified this girl & met her parents. She started to come to the multi-purpose center daily as well as received education support in evening. Sakina has passed Madhyamik exam classes and her education is still going.
